December 8th, 1948.

The regular meeting of the Local Board of Treestees of the Yellowknife Administrative District was held in the Court Room of the Government Office.

The meeting opened at 7:30 P.M. with Chairman Totzke presiding and Trustees White, Rudd, Bateman, Wilson, Hardie and Cole present.

Messrs. A. H. Gibson and J. G. McNiven and Trustee-elect Stanton were also present.

Mr. McNiven informed the Board that the proposal of extending the Grimshaw-Hay River Road was approved by the North-west Territories Council and is now at cabinet level.

It was moved by Trustee Bateman and seconded by Trustee Cole that Mr. McNiven be thanked for his work and the very able brief he submitted in favour of the extension of the Grimshaw-Hay River Road. The motion was carried.

Mr. A. H. Gibson informed the members of the Board that he had received a letter from Mr. R. A. Gibson asking him to draw the Board's attention to the indigent case of Mr. T. W. McSwain's family and to request the Board to have a more effective system of finding out of any people in our Community that are in need.

Mr. Gibson stated that Father Gathy had spoken to him about the matter of children living with Victor Dumont while their parents are in the hospital and that he was uneasy about the situation.

Trustee Bateman suggested that it be recorded in the minutes that this Board had no knowledge of the case in question; that Dr. O. L. Stanton, newly elected member of the Board be placed on the Relief Committee; that the Police and the Ministers be requested to inform the Board in future of anyone who they are aware are in need of relief.

It was pointed out by the members of the Board that this is the first they had heard of this case, and that they have never refused anyone assistance when they were in need.

The financial responsibility of relief was discussed by the Board. It was pointed out that in the Provinces the Provincial Governments accept this responsibility, and in the Northwest Territories the Northwest Territories Administration should accept it.

It was moved by Trustee Bateman and seconded by Trustee Wilson that the Northwest Territories Council be requested to declare their attitude with regard to the financial responsibility of relief issued in the Yellowknife Administrative District. The motion was carried.

It was moved by Trustee Bateman and seconded by Trustee White that the minutes of the meeting held on November 24th as drafted and mailed to the Board members be adopted. The motion was carried.

Trustee Wilson presented a plan of the proposed Public Toilets. He stated that he estimated it would cost \$4,700.00 for construction.

The Board were of the opinion that a Public Toilet at this cost would be prohibitive. It was suggested the executive of the Canadian Legion be approached and asked if part of their building could be used as a public toilet, and that they be paid rent for the use of the building, and that this Board would assume the cost of alteration. Trustee Wilson stated he would follow up the suggestion with the Legion and report back to the Board.

Trustee Wilson stated that he was of the opinion there should be more street lights on Latham Island. It was decided that the District Foreman contact Will Smith and inquire whether the Yellowknife Power Company have any lights available and if so to erect two more street lights on Latham Island.

Water rates for the Ingraham Hotel and the Red Cross Hospital were discussed by the Board. It was moved by Trustee Rudd and seconded by Trustee Bateman that the interim water rate for the hospital and the Ingraham Hotel be set at \$100.00 and \$200.00 respectively. The motion was carried; Trustee Cole dissenting; Trustee Hardie abstaining.

Appointment of an Operating Committee for the Yellowknife Arena was discussed by the Board.

After discussion it was moved by Trustee White and seconded by Trustee Cole that the following men be appointed the Operating Committee for the Arena: F. Miller, R. Sproule, Bud McPhee, N. McCann, N.W. Byrne with M. Hardie as temporary Chairman of the Committee. The motion was carried.

It was moved by Trustee Bateman and seconded by Trustee Rudd that the District make a grant to the Operating Committee of the Arena in the amount of \$150,00. The motion was carried.

Declaring December 27th (Boxing Day) a holiday was discussed by the Board. The Chairman was requested to wire Mr. R.A. Gibson asking him to declare December 27th a civic holiday.

The Chairman read a letter to the Board in connection with the District passing a By-law regulating the fees for licences issued within the Administrative District. He stated that the matter was discussed by the Northwest Territories Council and was not approved.

The Chairman read a letter from Mr. A. H. Gibson, Agent for Dominion Lands, requesting the Board to approve an application submitted by Mr. A.D. Wilmot for permission to occupy a plot of land 100' x 80' a parallelagram adjoining Lot "A" on Jolliffe Island.

After discussion it was moved by Trustee Hardie and seconded by Trustee Cole that application of Mr. A.D. Wilmot be approved; that this Board recommend the annual rental of this plot of land be \$7.50 per year. The motion was carried.

It was moved by Trustee White and seconded by Trustee Cole that the Secretary-Treasurer's Cash Statement for the month of September be received and filed. The motion was carried.

It was moved by Trustee Cole and seconded by Trustee White the meeting do now adjourn. The motion was carried.

At a meeting of the Interdepartmental Meteorological Committee held on December 9, 1948, it was intimated that, early in January, there would be a meeting of Canadian and United States officials to discuss next summer's weather station program and attendant supply problems in the far north. The names of Canadian observers whom it is desired to send on the expedition should be in the hands of the Secretary of the Committee before the preliminary meeting scheduled to be held on January 4. It was agreed in principle that (a) there should be a more complete briefing of Canadian observers; (b) all Canadian observers should be under the administrative control of a senior government official appointed for the purpose, and

(c) this control should be exercised through a senior Canadian observer designated on each ship. Council agreed that an administrative officer should be supplied and further consideration will be given to the appointment of a suitable man.

Ways and means of dealing with situations similar to that last summer when documents were removed from the Nares-Peary cairn on northern Ellesmere Island were also discussed. It was agreed in principle that the Archaeological Sites Ordinance be amended to cover such matters.

10. Central Lighting Plants maintained by Northwest Territories Power Commission -

In correspondence between the Deputy Minister and the Secretary of the Advisory Committee on Northern Development, reference was made to the need of an established policy which would prevent the construction and operation of duplicate small power plants in settlements of the Mackenzie District. The situation at Fort Smith, Hay River, Fort Norman and Good Hope bears on this. A report is being compiled by Mr. Humphreys, Technical Adviser of the Northwest Territories Power Commission at Hay River, which will be submitted in January. The item was placed on the Agenda to promote consideration of whether Council should deal with the Northwest Territories Power Commission for whatever power is needed at Fort Smith, Hay River, etc. It was agreed that the Northwest Territories Power Commission should construct, operate and maintain electrical plants sufficient for government needs (not to the exclusion of experimental or special needs of the Armed Forces) and if they are requested to supply power to other consumers, they might sell this as well.

11. Proposed visit of Mr. A. Y. Jackson to Yellowknife -

At the 186th Session of Council, mention was made of the possibility of Mr. A. Y. Jackson visiting Yellowknife. Dr. Keenleyside raised the question of paying all or part of Mr. Jackson's expenses on his proposed trip to the Mackenzie District. Council felt that this would be a satisfactory arrangement if Mr. Jackson planned to produce pictures which would be of special interest to the Northwest Territories Administration. The matter was allowed to stand pending Dr. Keenleyside's discussion with Mr. Jackson. In the meantime A/C Godwin is to investigate the possibility of transportation to Edmonton by R.C.A.F., and Mr. W. J. Bennett of Eldorado is to be asked about the trip from Edmonton to Eldorado.

The meeting then adjourned.
